King continues campaigning because he can't get off ballot

A Republican county commissioner candidate who had second thoughts about seeking his party's nomination is proceeding with the campaign after learning there was no way to get off the ballot.


Denny King, who is one of three candidates whose name will appear on the ballot in the May 8 primary, told party members attending this weekend's Haywood County Republican convention that he intended to withdraw from the race.

Robert Inman, director of the Haywood County Board of Elections, said he received a single page document from King asking to close a campaign finance account, but noted that has nothing to do with the ballot.

"The time for withdrawing is, by statute, the close of the filing period," Inman said.

Even though the primary election date is slightly less than two months away, election offices must have ballots ready to mail out next week. That means the ballots have already gone through the various approval processes and are already at the printer.

"Denny called me to say he made a decision late Friday afternoon that he doesn't want to run," Inman said Monday. "The law does not allow for anything to be done at this point. He does have some options. He can not actively seek the post. He can request that nobody vote for him or he can continue to run or just not accept the nomination

should he win."

Phone messages left on King's voice mail were not returned, but King responded to an email asking about the issue with this. "Please use the attached photo if needed during my run for commissioner. I am looking forward to this campaign."

King, who filed for office just before the filing deadline, became the third Republican candidate in a race where

two seats are open. Incumbent Commissioner Kevin Ensley and Waynesville resident Tracy Kevin Coward filed earlier, so King's entrance into the race meant a primary election would be needed. Those at the GOP weekend function said Coward didn't attend.

The winners of the Republican commissioner primary will face incumbent Commission Chairman Mark Swanger and Canton resident Mike Treadway.

Interesting question.

"King continues campaigning because he can't get off the ballot".

VERSUS

"King still a commissioner candidate after withdrawal not possible".

As a reader, I would be more likely to read the article under the first headline and thus prefer that one. It sounds more interesting, for starters. But also, it uses more active verbs.

The phrase "continues campaigning" is more active and lively than the word "still," which is a shortened version of "still is." In writing, active verbs are preferable over conjugations of the verb "to be."

Also, the phrase "can't get off the ballot" uses direct language, which is again more active and lively than "after withdrawal not possible," which is a prepositional phrase and thus is more passive in its construction.

Finally, the first headline uses shorter, simpler, more concrete words, and thus is just better writing and not as bureaucratic sounding.

Newspapers, one must remember, are not academic text books in terms of their writing style, particularly when it comes to headlines.

We have a joke in our office when it comes to writing headlines. One can have clever and cute, or one can have accurate, but one cannot have both. Again, just a joke! Let me reiterate: just a joke! We actually try to be both clever and cute and accurate – and feel very proud when all of those are able to converge and very sad when we have to forgo a clever pun for gosh-darn accuracy sake.

Hope this provides a little insight, but not speaking for the Mountaineer by any stretch of the imagination.

Mr. Inman,

Thank you for taking the time out of your busy schedule to sit down with me in your lobby to answer the questions I posed to you in my March 20th letter.

- You indicated right off the bat you have no political views on any candidates.
- You were not aware of any state agencies that govern newspapers and newspaper articles.
- Your middle name is “Dewey” and you are the Inman that lives in Maggie Valley.

[After rechecking the voter registration records with this new information, your party affiliation is DEM.]

You volunteered that your office of **Haywood County Elections** is governed by the North Carolina State Board of Elections, and if I found out any agency or statute that related to newspapers or newspaper articles, to be sure to let you know.

Did you know that there is a whole chapter on **Elections and Election Laws**? It is Chapter 163 of the North Carolina General Statutes. It was brought to my attention that the following section could apply to newspaper articles, such as the Hit Piece recently published on-line and print version in the Mountaineer newspaper [only relevant sections (7) and (8) reprinted here]:

§ 163-274. Certain acts declared misdemeanors.

(a) Class 2 Misdemeanors. – Any person who shall, in connection with any primary or election in this State, do any of the acts and things declared in this subsection to be unlawful, shall be guilty of a Class 2 misdemeanor. It shall be unlawful:

(7) For any person to publish in a newspaper or pamphlet or otherwise, any charge derogatory to any candidate or calculated to affect the candidate's chances of nomination or election, unless such publication be signed by the party giving publicity to and being responsible for such charge;

(8) For any person to publish or cause to be circulated derogatory reports with reference to any candidate in any primary or election, knowing such report to be false or in reckless disregard of its truth or falsity, when such report is calculated or intended to affect the chances of such candidate for nomination or election;

(b) Class 1 Misdemeanor. – Any person who shall, in connection with any primary or election in this State, do any of the acts and things declared in this subsection to be unlawful shall be guilty of a Class 1 misdemeanor. It shall be unlawful for any person who has access to an official voted ballot or record to knowingly disclose in violation of G.S. 163-165.1(e) how an individual has voted that ballot. (1931, c. 348, s. 9; 1951, c. 983, s. 1; 1967, c. 775, s. 1; 1979, c. 135, s. 3; 1987, c. 565, s. 13; c. 583, s. 9; 1993, c. 539, s. 1112; 1994, Ex. Sess., c. 24, s. 14(c); 1993 (Reg. Sess., 1994), c. 762, s. 58(a)-(c); 1999-424, s. 7(h); 1999-426, s. 2(a); 1999-455, s. 21; 2007-391, ss. 9(b), 16(b).)

Goodness!

Now see the potential problems you can unwittingly get into when you give interviews? This, by the way, is one reason that I do not give interviews. Someone can print a piece in a newspaper, slap a title on the piece, fail to provide any hint who authored the article (anonymous), and before you know it, it appears to look like a democrat Hit Piece, and you become part of it. Did you notice the penalties in **§ 163-274. Certain acts declared misdemeanors**? Both Class 2 and 1 Misdemeanors.

Being associated with stuff like this can put you on the radar.

I'll continue to check around to see what agency takes the responsibility for the enforcement of **§ 163-274. Certain acts declared misdemeanors**, whether it is the North Carolina Board of Elections, the Attorney General or other entity(s), and let you know when I find out.

Mr. Miller,

I wrote the headline for the Denny King story in The Mountaineer's print edition of March 14, 2012. As to my choice of wording, I'll defer to Ms. Johnson's earlier explanation of what makes a compelling and accurate headline.

The online and print headlines differ simply as a matter of workflow and good newspaper design. Writers submit stories online with headlines that often don't fit in the allotted print space. With the help of a thesaurus and some pretty good Scrabble skills, I write accurate, concise and interesting headlines that don't interfere with a coherent page layout.

I made a mistake by not including Vicki's byline on the story. It was an oversight for which I am solely responsible. I can assure you there was no deliberate attempt to conceal the authorship of the story. I had a very long day the Tuesday prior (as I wear several hats here) and simply screwed up, as I am wont to do from time to time.

To save you a little legwork: I'm a registered Democrat, usually vote for Democratic candidates (even at eight years old, I encouraged my dad to vote for Jimmy Carter when he took me in the voting booth in 1980) and have written for liberal publications, although not often.

I appreciate your attention to my mistakes. I am always open to feedback on my work, although I seldom make time to respond personally.
