Pat Carr released an e-mail to an unknown number of Haywood County Republicans (from a list that she will not disclose to Executive Committee Members) this morning at 1:26am. Her e-mail culminates several days of unrelenting pressure on Carr and her husband, Ted Carr. We have seen the Haywood County GOP website yanked off the air (<http://www.haywoodncgop.org>), yet she refers to it in her e-mail.

Pat Carr's Dirty Laundry regarding Haywood County GOP is being posted on [www.haywoodtp.net](http://www.haywoodtp.net) when she opened Pandora's Box by colluding with Vicki Hyatt to write a Character Assassination Hit Piece on Eddie Cabe -

It is interesting to note in Pat Carr's e-mail a couple of significant items.

- She does not yet challenge the resolution passed by the Executive Committee before the meeting on 1/8/2015 actually adjourned,
- She continues to reference the defunct Haywood County GOP website, <http://www.haywoodncgop.org> which was pulled a couple of days ago.

Hello Haywood County Republicans

At the Jan. 8th Executive Committee meeting, the published agenda included a discussion of the 2015 County Convention, however the meeting was adjourned before the topic was reached. I am excited and pleased to share with you the following information.

The 2015 Haywood County Republican Party Annual Precinct Meetings and Annual Convention will be held the morning of Saturday, March 14, 2015. The location will be the Canton Armory, at 71 Penland Street.

An official announcement will be published in a local newspaper in late February. A Press Release has been drafted and will be sent to The Mountaineer and the Smoky Mountain News encouraging all Republicans who are registered as of January 31, 2015, to attend.

I plan around Feb. 1, for the HCGOP website to contain an announcement of the same information. It will also be emailed to all Republicans listed in our database.

The Convention Chairman will be Ted Carr. The first draft of the schedule has been prepared. We are still awaiting responses from a few more folks. In mid Feb., the schedule will be placed on the website and emailed to all Republicans in the database.

I have appointed Mr. K.G. Watson as Chairman of the Plan of Organization Committee. Mr. Andrew Jackson indicated he too would be willing to serve on the Committee. Anyone else interested in serving should send an email to me at [carr4pat@aol.com](mailto:carr4pat@aol.com), with Plan of Organization Committee in the subject line.

I have asked Ms. Judy Jones to serve as Chairman of the Credentialing Committee. Her name along with the other nominees for the Committee, will be presented for approval by the Executive Committee at the February meeting.

We also need to decide at the February meeting whether to have Precinct Meeting training a week or two before the Annual Precinct meetings.

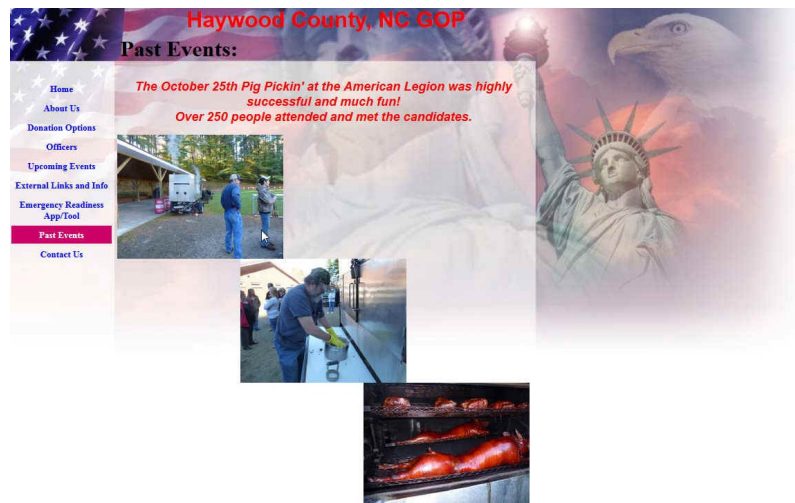
