Well, well, Mr. Lyons,

So, you were sent by NCGOP to "resolve" Eddie Cabe and I?

Indicating to Eddie during a phone conversation today that you were coming after both of us for e-mail harassment of Pat Carr?

Well, here is another tid-bit of information for you.

I captured the source code for the Donate Page on [www.haywoodncgop.org](http://www.haywoodncgop.org) before the plug was pulled, and that has been turned over to Law Enforcement. Additionally, I provided law enforcement with a DVD of the entire meeting of 1/8/2015, where Pat Carr confesses, among other things, that she did not know the password to the PayPal account, and threw Tracy Coward under the bus.

Here are some questions I have, and maybe you can extract answers out of Pat Carr and we can close this whole thing down before a criminal case file is opened:

- Who had access to the PayPal account? When PayPal was contacted, there is a drivers license of record of the person who has access to that account. Also, the person lives in Waynesville, with a Waynesville ZIP code and telephone number. There is no balance left in PayPal, as funds are regularly drawn out,
- What has been the amount of money passing through the PayPal account over the last two years?,
- Who is at the other end of the e-mail address: [treasurerhaywoodgop@gmail.com](mailto:treasurerhaywoodgop@gmail.com) ? This address was discovered embedded within the source code of the Donate page, and gets a notification every time there is a transfer into the account, whether by PayPal or a credit card?

Sometimes, a little research on the background of something as volatile on this would seem to have been worth your while before you landed on someone.
