Subject: HCGOP votes to censure Pat Carr [R] and Kevin Ensley [R].

The Haywood County GOP Executive Committee voted to censure Pat Carr, previous Chair, who was thrown out of office at the HC GOP County Convention in March, and Kevin Ensley, current sitting Haywood County Commissioner. The vote occurred at a regularly scheduled meeting on July 27, 2015 starting at 6:30 pm.

The following two Resolutions were voted upon and passed as motions by the HCGOP Executive Committee. The purposes of these censure resolutions were two-fold.

- Pat Carr - These actions may rise to the level of Party Disloyalty, and if the process is carried out, will strip Pat Carr of any current elected/appointed position, and
- Kevin Ensley - will pave the way for HCGOP to support more conservative alternative Republican candidates in the 2016 Haywood County Commission election.

RESOLUTION TO CENSURE PAT CARR [R]

WHEREAS, Pat Carr disenfranchised twenty-five (25) people from becoming District and State Delegates by manipulation of signed little slips of paper filled out by people attending the Haywood County GOP County Convention; and

WHEREAS, Pat Carr created a credentials committee which included Hannah Strum; and

WHEREAS, Pat Carr delivered a “Final” Delegate list in the form of a printed out spreadsheet to HCGOP officials to forward to NCGOP within a ten (10) day time constraint, but intentionally withheld the original little slips that people filled out at the county convention; and

WHEREAS, Peoples reasonable expectations by filling out these little slips of paper was that they were filling them out to become delegates to District and State Conventions; and

WHEREAS, Pat Carr manipulated and falsified the data resulting in some being included while others were excluded in a deliberate fashion; and

WHEREAS, Pat Carr withheld the original little slips of paper from HCGOP officials until after the ten day time limitation had passed, so it was impossible for HCGOP officials to independently verify the results of this tally; and

WHEREAS, Twenty-five people were disenfranchised from becoming Delegates; therefore be it

RESOLVED, It is the vote of the HCGOP Executive Committee that Pat Carr is censured for this act.

Approved by a vote of the HCGOP Executive Committee by a vote of 11 FOR, 2 AGAINST, 1 ABSTAIN.
Motion Passed.
