I am filing a formal complaint against Angela Moore Lytton for seeking and holding the Office of 2nd Vice Chair of the 11th District in violation of the North Carolina Party Plan of Organization, Article VII, (A) (1) (b).

Since this is the first formal complaint I have filed with the NCGOP, I request that you forward this complaint to whomever it should go, but specifically include David Williams.

Please let me know if you require this complaint to be notarized.

The following is the relevant section of the PPO:

ARTICLE VII - GENERAL ADMINISTRATIVE PROCEDURE

A. CONVENTION PROCEDURES

1. Annual Conventions and Presidential Election Year Conventions

b. No member of a credentials committee created by this Plan shall be eligible to be elected to an officer or executive committee position at the convention for which the credentials committee serves, nor shall a committee member publicly support anyone for an office to be elected by said convention. Except when voting in convention, members of credentials committees shall strive to maintain the integrity of the convention and the committee by conducting the business of the committee with impartiality and strict neutrality on the business and elections of said convention.

From memory, the members were Shirley Slaughter, Linda Sawyer, Angela Lytton and perhaps one other. At the end of the discussion following the presentation of the report, Angela made a motion to correct the report. Her motion dealt with the timing and completeness of the individual county delegate lists. She was ruled out of order as the State POO is explicit about when the lists must be submitted.

I am not aware of what delegate activities transpired prior to the actual convention, but there was conversation regarding late and missing information from several counties. To the best of my knowledge, the county reports filed or not filed with the state and district were considered to be the only true delegate lists.

I would recommend that you contact Cynthia if you would like more information.
