STATE'S MOTION
TO MODIFY
DEFENDANT'S BOND
& NOTICE OF HEARING

NOW COMES the State of North Carolina, by and through the undersigned assistant district attorney, and, pursuant to N.C. Gen. Stat. § 15A-539, hereby respectfully requests the Court to modify Defendant's conditions of release and, in support thereof, states as follows:

1. That Defendant is charged with Misdemeanor Driving While Impaired and Felony Serious Injury by Vehicle arising out of events allegedly occurring on December 24, 2015. Upon information and belief, Defendant thereafter completed a 28-day inpatient treatment program.

2. That, upon Defendant's release from this program, the alleged victims in the criminal cases saw Defendant operating a vehicle in or near Waynesville, North Carolina. Further, on or about February 20, 2016, Lieutenant Tyler Trantham of the Waynesville Police Department saw Defendant sitting at the bar of a local restaurant with a wine glass in front of her containing a liquid similar in appearance to wine.

3. That the medical records of Defendant diagnose Defendant with alcoholism and cirrhosis.

4. That it is appropriate and necessary, given Defendant's history and the facts of this case, that the Court either:

a. Order Defendant to not operate a vehicle upon the streets or highways of North Carolina during the pendency of her case;

b. Or, in the alternative, order Defendant to not possess or consume alcohol during the pendency of her case, and that Defendant shall be monitored by a continuous alcohol screening device at her expense.

WHEREFORE, the State would respectfully request the Court to modify Defendant's conditions of release as described herein or as the Court would otherwise deem just and necessary in order to protect Defendant and the motoring public.


