•	Contract for technical guidance	\$25,000
•	Contract for permit boundary modification	\$30,000
•	Contract for White Oak Landfill capacity study	\$14,300

Ah-ha!, I thought. These reports surely have to be complete and paid for, so I will request to see a copy of these reports. Welcome to nightmare city. The last correspondence I received from Candace Way was letting me know: "David Francis has the other part of your request r.e. Francis Farm and will provide those documents when he is able."

Translation: Go [Expletive Deleted] yourself!

The first time I ran into this mentality was with Julie Davis. I had asked to see a copy of one of the Budgets that was just about to be released in an upcoming County Commission Meeting. She indicated that she could not let me inspect or have a copy until it had been approved by the commissioners. Well, I have news for Julie Davis (who should be sitting comfortably in an 8 x 10 room at a Federal Institution right now), that if Julie Davis picks up a pencil and a piece of paper that was purchased by the county, and makes a mark on it, that becomes Public Information. I have the right to see it.
