# Harlingen man faces child porn charges

► BROWNSVILLE — A Harlingen man has been indicted by a federal grand jury with production and possession of child pornography. Eugene Daniel Atwood, 37 1325 Cottonwood Blvd., was charged with two counts of production of child pornography in a Tuesday indictment. Atwood was arrested on Sept. 28 by Harlingen police after employees at an EZ Pawn store near the police station discovered lewd photos of Atwood with a young boy in a laptop computer Atwood had pawned, but not redeemed. No date has been set for Atwood's appearance in a federal court in Brownsville, the Justice Department said. At that appearance, a trial date will be announced. Each of the first two counts which accuse Atwood of receiving child pornography and possessing with intent to distribute obscene material carries a statutory penalty of a maximum of 5 year to 20 years imprisonment upon conviction.

► RIO GRANDE CITY — Two thousand federally endangered star-cactus plants have been found on a 415-acre piece of land purchased Wednesday by the Nature Conservancy of Texas.

The new Las Estrellas Preserve is the first protected area for the plant, which is found only in Starr County and parts of Mexico extending to Monterrey, said Lisa Williams, the conservancy's project director

The spineless, round star-cactus has eight sections and white tufts that make it look like a "spineless sea urchin," Williams said. The organization paid the landowners \$228,000, a grant funded by

# Casino owner dies hours after leaving jail

# **Death:** Family blames police for handling of arrest. **BY SERGIO CHAPA**

Family members of video casino owner Jose Luis Bazan said they blame police for his sudden death Tuesday — hours after he surrendered on three gambling charges.

The family's attorney Ernesto Gamez said Bazan, 53, began to have severe respiratory problems shortly after his release the same morning.

Gamez said Bazan later died from an apparent heart attack

for the respiratory problems at a Matamoros hospital

"His wife is e x t r e m e l y depressed and blames police for the way they handled her husband's arrest and the seizure of his property," Gamez said. "He was quite a gen-tleman ... an elderly man, who

had never been in trouble before." Brownsville Police Chief Carlos Garcia said police did not do anything out of the ordinary with Bazan's case.

On Monday, police seized 92 video casino machines from Palace Arcade, 2921 Boca Chica

#### while he was receiving treatment Blvd. A probable cause affidavit said the arcade was making illegal payouts and identified Bazan as the owner.

Bazan was then charged with keeping a gambling place, gambling promotion and possession of gambling devices.

All three charges are Class A misdemeanors punishable up to one year in jail and/or a \$4,000 fine. "We did not encourage him (to)

engage in any criminal activity," Garcia said. "The family needs to reflect on this. Our continuing investigation will show that he made a lot of money through his illegal activities."

Under state law, police are required to provide medical treatment to prisoners, but a Brownsville City Jail log said Bazan only spent 27 minutes in custody Tuesday morning — from 10:53 a.m. to 11:20 a.m. Gamez said Bazan died late Tuesday afternoon.

Garcia said Bazan did not even set foot inside a jail cell.

"We gave him the red carpet treatment," he said. "We allowed him to turn himself in the company of his lawyer. He was processed and arraigned quickly."

Gamez said the night before a deputy constable tried to arrest Bazan for the warrants and threatened to arrest a family member at his home.

The deputy constable was not identified Wednesday night.

Gamez said there are no plans, for a lawsuit at this time, but he said he plans to discuss the incident further with Garcia.

# County's attorney faces DWI charge

Police charged Wright with driving while intoxicated and striking a fixed object. Rodriguez said he was released after posting \$1,000 in bonds.

Cameron County Judge Gilberto Hinojosa said the court has not taken any "significant" action against Wright.



He was also arrested for driving while intoxicated.
