Kevin Ensley: “The other item I wanted to mention is I had gone to a, uh, fund raiser for Sarge's, uh, this past week, and I just wanted to let everyone know Sarge's, uh, is they partner with the county, uh, for and do adoptions at the Animal Shelter, and, uh, they, they've probably, since they've been in existence, they've been able to adopt out over 11,000 animals that they've saved, and I think just this year, if I got my numbers right, it's 421 from the Animal Shelter. And when Sarge's does adoptions, they, uh, one, one of the great things in this partnership, is they actually, uh, put out more money than they take in from the adoptions. So, their fund raisers are real important. that we give, uh, you know, when they have those fund raisers, because it supplements their income from the adoptions. So, uh, we're thankful for them, and we appreciate their service to the county. And this shows how a partnership can really help our community, it saves taxpayers money, and more importantly, it saves lives of some of God's creatures. Um, they were telling me, that, over in, uh, if they've gotten a call from down east, I think there was a county that 75,000, I mean 75 %, uh, euthanasia rate, so 75% of the animals were being killed in the shelter, and so they had called Sarge's in the, in the Animal Shelter up here to find out what they could. Un, the, uh, euthanasia rate, I think it's either 3.9 or 3.6% now, and that, if that's not the highest in the state, it has to be one of the highest. So I just want to thank them for there, uh, efforts, and, uh, in, in doing the adoptions and, and for this partnership (garbled) I want to let the county commissioners know that this is one partnership that's working.”
