**Subject:** Partial Transcript of Lynda Bennett at Cherokee County, NC, GOP Convention, 3/5/2020.

**Lynda Bennett** showed up unannounced at the Cherokee County GOP Convention on 3/5/2020. Shannon Greathead, an attendee, had an audio recorder. This is her summary of what transpired at the meeting.

This latest information comes to you out of the meeting as a 17:18 audio unedited directly from the Cherokee County, NC GOP Convention that was held last night at Headquarters in Murphy, NC 3/5/2020. Guest speaker was Republican candidate running for 11 District Congressional seat Lynda Bennett.

There is going to be a run-off election May 12th with her opponent Madison Cawthorn.

In this audio clip you will hear Ms. Bennett discussing her platform for what she is wanting for residents of NC and wanting to work with TRUMP in the future. She starts discussion on internet and infrastructure and gets told that our area schools do not have internet in the lower end of the county in Hiwassee Dam.

As the discussion continues you will hear Ms. Bennett then start talking about the recent audio clip that circulated about "Never Trumper" claims. She even names several residents from the local GOP in her county by first name but specifically calling out one in particular as if there is a problem more so with him than anyone else named "Eddie" as if everyone should know him.

1. First question asked was by me as to her response to the recent article from Smoky Mountain News in regards to her ties to Jane Bilello and the accusations of campaign finance funds violations. Her responses were at first to say she did not know what I was asking and was deflecting back to the previous conversation about her support for Trump See what you think by listening to the audio. At one point in the audio of her back and forth there is a gentleman that interrupts twice throughout the audio recording. Saying that we need to stop beating a dead horse. We of course still get no answers.

With that being said I would like to point out. There is a reason for questions and answers and if a person does not answer the first time you ask it in a different manner. I really wished people would stop interrupting it is rude. Just saying.

2. Second question asked was by another member of the community if she was a member of the Tea Party in which she denies, then says she is friends with them and has associations with, but then was again asked wait are you denying you were ever a member. \*\* There were recent documents just released of her membership in the Tea Party. Not sure why she is denying that.
3. She was then asked by Leo Phillips to come on to the Mountain Voice Conservative Talk Radio Show, with the offer of airing the previous "supposed doctored" audio that is 30 minutes long and give her the remaining time of an almost hour long radio show to give her explanation of what happened as she was doing in the room tonight. FOR FREE ADVERTISEMENT...to the constituent's of Cherokee County and NC that listen to this broadcast far and wide. This is her opportunity to openly have the time to do so without interruption and she denied it blowing it off with its on social media it's not mine..but refused to go on air.

Not sure why any candidate would refuse free air time advertisement when they are wanting to win an election and get voters...there are just a little over 21,000 registered voters in Cherokee County. So Ms. Bennett you said to me you wanted my contact information so you could forward the information from your attorney that was sent to the Board of Elections regarding the allegations on the campaign violations...are you going to keep your word? I sent you a message this morning. I will fairly put that information out.

The transcription starts at 5:47 into the audio and ends at 9:17. At about 6:39 into the audio, **Lynda Bennett** decided to "tell a story".

[**Editor's Note:** Quote by Ronald Reagan: "If you're explaining, you're losing."]

This story lasts approximately two and a half minutes [ 6:39 - 9:14]. In this story, **Lynda Bennett** describes the events at the 9/22/2016 meeting. Unfortunately for **Lynda Bennett**, that's all this is, a story. Practically everything is a fabrication, not backed up at all with the two recordings I posted on [www.haywoodtp.net](http://www.haywoodtp.net) on 2/6/2020.

I invite you to review the two audio recordings I made on 9/22/2016, along with the descriptions I posted for each section (Part I and Part II) of the recordings.

- 5:47 ... I want to say another thing. There's, um, some fake news that was spread, has been spread. Um, hundreds of thousands of dollars has been spent on fake news. The source of that news, about an audio tape that claims I was a never Trumper, the source of that news (garbled), the source of that news was, um, a PAC, that supports democrats.
- 6:10 It supports minor Republicans that are running against people that are going to join the Freedom Caucus. So it's a direct attack against me because of my principles and that I am going to join the Freedom Caucus. That audio! How did this fake audio get created, or this fake news get created?
- 6:32 So the audio was doctored. And by that, what I mean is - I'm gonna tell you a story, because you need to know the truth.
- 6:40 When I was in our headquarters, similar to this, very ..., a couple of us got together, we were going to get together to put together our palm cards. After the primary is over - I know that I'm still in the primary, but most of your candidates have already been selected. You know who your candidates came through the election that they deserve to be on the palm cards should be no discussion.
- 6:55 Five guys walk in the door, and it's a faction, a well known faction in Haywood County, and they said, "No". We're not going to put your candidates on that palm card we don't like, and we're not going to list Jim Davis if you (unintelligible) on there. One of them was one of our commissioners, I fought hard to keep him on there. These guys have earned their position.
- 7:14 I didn't care what they thought, they were five guys. Ten thousand people had come out and voted for our candidates, and they did not get to override the voice of the people at that point. Well, I wasn't the only one fighting (unintelligible), there were others. But, they got into such a heated debate, such a loud discussion, that they, I thought they were going to have a fight. One of the guys I thought was going to have a heart attack.
- 7:38 But they ended up in court. They got so mad at each other, they sued. So, in that environment, I'm a little agitated. I'm like, we need to get this done. We respect all the people that came in to volunteer that were going to hand out the palm cards - we're going to create a calendar - we're gonna do all this work, they left!
- 7:54 So, I was getting frustrated. And I said: You guys are never going to vote for -, and I used Jim and Mike and Kevin and all these people, people you would know, you're not going to let us put them on the cal-, palm card, you sound just like the never trump. And I said, there's never gonna be - uh, your never gonna get your way, we're not gonna go that way, we're gonna do what's right, and, there's conversations going on, and I said to this guy, who has shared this ten thousand times on the internet, I said, Eddie, I'm being facetious.
- 8:27 He knew I was being facetious, he knew that means joking. So, the end result was they took a, they recorded - they told me they only had a little bit, and I kept saying just release the tape. The truth will come out. Let us know what's true. They would not release that tape for three years.
- 8:46 On Thursday before the election, they finally released thirty minutes of the tape. And on it, it says, this is what I'm hearing, I quoted what I heard those never Trump, I said, Eddie, I'm being facetious, and the Chair of the Haywood County Republican Party, you can hear his deep voice saying, She's a big Trump supporter. There's the facts. That is what you will hear on that tape if you go through all the mish-mash, your gonna hear that. So I knew, if I could get that truth out, that I didn't have anything to worry about. But, in the meantime, ...

End transcribing.

This “story” is so far afield, that **Lynda Bennett** ought to be nominated for an academy award for something. Were we even at the same meeting? Since so much of this “story” is a fabrication, the best way to go through this is paragraph by paragraph, using the time on the tape to separate the paragraphs. So here we go...

5:47 ... *I want to say another thing. There’s, um, some fake news that was spread, has been spread. Um, hundreds of thousands of dollars has been spent on fake news. The source of that news, about an audio tape that claims I was a never Trumper, the source of that news (garbled), the source of that news was, um, a PAC, that supports democrats.*

I can’t speak for Eddie Cabe (who she refuses to provide his last name, and I don’t even get an honorable mention) but we certainly did not spend hundreds of thousands of dollars providing accurate information over the internet. Eddie also disseminates information on Facebook - I am not on Facebook.

Perhaps **Lynda Bennett** is confusing us with FIX CONGRESS NOW, a PAC that sent out five (5) flyers through the USPS that one could call negative. Additionally, according to Ally Mutnick of Politico, she indicated a series of text’s were sent on or about January 31 to anyone and everyone in Washington and elsewhere, including a Politico reporter, an audio of **Lynda Bennett** screeching she is a never Trumper. It is unclear who sent those text messages.

The source of that news was **not** a PAC, it was my recording. By the way, there were two recordings made using a digital recorder. There was never any tape, and **Lynda Bennett** continues to refer to.

6:10 *It supports minor Republicans that are running against people that are going to join the Freedom Caucus. So it’s a direct attack against me because of my principles and that I am going to join the Freedom Caucus. That audio! How did this fake audio get created, or this fake news get created?*

It is not clear to me who the PAC supports. This is conjecture by **Lynda Bennett**.

The (two) audio recordings I made during the 9/22/2016 meeting at HRA Headquarters are not fake. They are as clean as the driven snow.

6:32 *So the audio was doctored. And by that, what I mean is - I’m gonna tell you a story, because you need to know the truth.*

This has been **Lynda Bennett’s** mantra since the short audio/video was first put out. I put the short audio/video, generally attributed being created by **Paul Yeager**, on my website, [www.haywoodtp.net](http://www.haywoodtp.net) on 10/28/2017.

Comparing the audio from this short audio/video clip against my original recording reveals that the short audio/video is a faithful replication of the original recording. It has not been doctored. Listen for yourself.

Now we are going to hear a story. Get ready folks, here it comes...

6:40 *When I was in our headquarters, similar to this, very ..., a couple of us got together, we were going to get together to put together our palm cards. After the primary is over - I know that I'm still in the primary, but most of your candidates have already been selected. You know who your candidates came through the election that they deserve to be on the palm cards should be no discussion.*

It was not her headquarters.

**Lynda Bennett** called a meeting together on September 22, 2016, for the purpose of organizing volunteers to man the Haywood County precincts for the November election. **Lynda Bennett** specifically invited three (3) other people for this little committee:

- Steve Lansing
- **CHARLES DOUGLAS WRIGHT**
- **Cornelia Cree**

Since the HCGOP (Haywood County GOP) had no office at the time, **Lynda Bennett** requested from HRA (Haywood Republican Alliance) that she could use the HRA headquarters for the meeting. Richard West had a key and opened the headquarters for this meeting. This was an open meeting, open to anyone interested in attending. In all, there were about thirteen people, including some members of HRA.

Some of the attendees were:

- **Lynda Bennett**, Steve Lansing, **CHARLES DOUGLAS WRIGHT**, **Cornelia Cree**
- Richard West
- Eddie Cabe
- **Ken Henson** (HCGOP Chair)
- **Debbie King**,
- myself, and a few others.

[**Editors Note: Cornelia Cree** was since thrown off as a board member of the Haywood County Board of Elections for violating her oath.]

The meeting was never about palm cards, but the subject did come up during the meeting. Again, referring to the two recordings of the meeting:

6:55 *Five guys walk in the door, and it's a faction, a well known faction in Haywood County, and they said, "No". We're not going to put your candidates on that palm card we don't like, and we're not going to list Jim Davis if you (unintelligible) on there. One of them was one of our commissioners, I fought hard to keep him on there. These guys have earned their position.*

No body walked in the door. There were initially three (3) members of HRA in the room, prior to **Lynda Bennett** starting the meeting. They were:

- Richard West, he had the key to the HRA headquarters,
- Eddie Cabe,
- Myself.

This whole thread of palm cards is totally fictional . Exactly where on my two recordings does any of this take place?

One portion of my second recording which directly contradicts **Lynda Bennett** standing up for **Kevin Ensley** is found here:

7:14 *I didn't care what they thought, they were five guys. Ten thousand people had come out and voted for our candidates, and they did not get to override the voice of the people at that point. Well, I wasn't the only one fighting (unintelligible), there were others. But, they got into such a heated debate, such a loud discussion, that they, I thought they were going to have a fight. One of the guys I thought was going to have a heart attack.*

What five guys? Who were the others that were fighting with you?

Here is the real description of what happened during the first part of the meeting where I was asked by Ken Henson to turn off my recorder

The meeting started at around 5:34 pm, and ended at approximately 6:40 pm. I was asked to turn off my audio recorder [re: 160922\_001, 24:48 minutes in total duration] at around 6:00 pm by **Ken Henson**. **CHARLES DOUGLAS WRIGHT** then communicated a threat to me, stating "BACK OFF OR ELSE THERE WILL BE BLOOD RUNNING OUT BOTH YOUR EARS", [re: 16 CR 53432]. I then turned my recorder back on [re: 160922\_002] for the rest of the meeting, which took a decidedly different tone.

Additionally, I took hand written notes during the meeting, which included an attendance list of everyone present. My notes are on the following page. This has been lightly redacted. However, none of the people in the attendance list who were redacted was **Pat Bennett**.

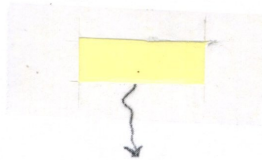

Kate Wrenn, Haywood County ADA prosecuted the case. Eddie Cabe and Richard West testified on my behalf. I took some handwritten notes that day, explaining to Kate Wrenn what had happened on 9/22/2016.

The following are notes I took while describing to Kate Wrenn the account of 9/22/2016. There is a diagram which are two standard fold up white tables that everyone was seated around. I was at one end of the two tables, and **Lynda Bennett** was at the other end. At all times, **Lynda Bennett** was aware that I was recording the meeting, as my recorder was clearly situated on the table. This is relevant, as when I turned my recorder back on at 6:04 pm, and **Lynda Bennett** started screeching she was a Never Trumper, I pointed to my recorder, which is when she made an interesting comment (recording, Part II).

The other interesting point was the locations of **CHARLES DOUGLAS WRIGHT**, **Cornelia Cree**, and **Lynda Bennett**, all basically sitting right next to each other. **Ken Henson** was walking around.

**Monroe A. Miller Jr.**, being first duly sworn deposes and says:

1. I am a Haywood County Taxpayer, and have lived in Haywood County since 2004.
2. That DONNA FAY FORGA is scheduled to hear my case on Tuesday, February 7, 2017, 16CR053432 in District Court, re: CHARLES DOUGLAS WRIGHT Communicating Threats.
3. That DONNA FAY FORGA sat as Vice-Chair on the Haywood County Board of Trustees during the period of time that the Board of Trustees was preparing to go before the Haywood County Commissioners for financing of the Creative Arts Building.
4. That Rose Johnson was President of Haywood Community College at that time, and Mark Bumgarner was Chair of the Haywood Community College Board of Trustees.
5. Prior to the presentation to County Commissioners, the Board of Trustees voted unanimously to approve the building plans for the Creative Arts Building. However, the Board of Trustees was split nearly 50/50 about approval of the FLS Solar Thermal portion of the project.
6. During the Public Comment Session at the Haywood County Commission Meeting on September 7, 2010, I made a Public Comment [re: Haywood County Commissioners Minutes, Regular Meeting, 9/7/2010]. From the minutes of that meeting:

“Monroe Miller stated that Dr. Rose Johnson, President of HCC, failed to provide the HCC Board of Trustees the FLS contract and refuses to answer his questions regarding the proposed Creative Arts Building. Mr. Miller summarized the decisions made at the HCC Board of Trustees meetings held August 30<sup>th</sup> and September 2<sup>nd</sup>, 2010. Mr. Miller urged the Board to table this motion for 90-120 days until the HCC Board of Trustees makes its final decision regarding the FLS Solar portion of the final contract.”

7. Once I alerted Rebecca Morgan, Secretary to the Board of Commissioners at that time, that there were irregularities that occurred during the September 7, 2010 meeting, the entire context of the meeting regarding the HCC contract was entered as a Verbatim Transcript into the minutes.
8. I had alerted several county commissioners prior to the September 7<sup>th</sup> 2010 meeting that there was a split vote with the FLS Solar portion of the contract.
9. Chairman Kirkpatrick, during the meeting, asked the following of Mark Bumgarner, who was standing shoulder with Rose Johnson and DONNA FAY FORGA,

“... I guess where I come down is, is if you had come in here today and I want to ask you this again to make sure, but if you’d come in today and there was a still a 6 / 5 decision I probably would be in line with Kevin right now because I would feel uncomfortable with the board coming in that you don’t have a real good consensus, but you’re telling me, Mark, that you all voted on it, or you had the approval. I don’t know if there was a vote or not, but you, you looking at me now have the approval of everyone on your board to move forward with this project.”

10. Mark Bumgarner responded, standing shoulder to shoulder with Rose Johnson and DONNA FEY FORGA, that:

“Yes, Sir. We’ve had eleven board members and that all unanimously agreed that, on the construction costs and the budget request, loan request amount, 100%.”

11. DONNA FAY FORGA failed by omission, to correct Mark Bumgarner, that the board did not unanimously agreement on the FLS Solar portion of the contract.

12. I wrote the following in my Haywood County “Toeprints”, September 9<sup>th</sup> 2010, Vol.#1 Issue #3, the following:

“It appears to me that there might have been a slight bit of deception on the part of **Bumgarner, Donna Forga** (who is running for District Judge in Nov.) and **Rose Johnson** (who all stood at the podium) in misleading the commissioners to believe the Board of Trustees “... were unanimous”. [Perhaps **Bumgarner** and **Forga** might consider stepping aside from their current positions as Chair and Vice-Chair, respectively, on the Board of Trustees at this time]. It is now left up to the discretion of the HCC Board of Trustees to determine if the Solar Thermal portion of this project will be approved - **not** the county commissioners any more.”

13. In a subsequent meeting with DONNA FAY FORGA, in a parking lot of a restaurant in Maggie Valley at a Republican political gathering, I confronted DONNA FAY FORGA on her Integrity, where DONNA FAY FORGA was reduced to tears.
14. DONNA FAY FORGA has no standing to sit before me in any court hearing to make any judgement on me at all, and must recuse herself from this case. Her best course of action would be to grant a continuance before another Judge, excluding Kristina Earwood.

I swear under pains and penalties of perjury that the above is true and accurate.

This document is hereby recorded pursuant to Rules of Federal Evidence, 901 and 902. The preceding items of evidence are self-authenticating or identifying evidence; they require no extrinsic evidence of authenticity in order to be admitted.
