Complaint.

This is a complaint against Zebulon Loranzo Smathers, a.k.a. Zeb Smathers, for the following.

- Representation of a defendant, Ed Smathers, in 22CVD401/22CR50955 combined cases, for which Zeb Smathers stated, in writing, that: "I do not represent Ed Smathers on any civil matters.", and yet he did, and,
- Dissuading witnesses in cases 16CR053432 and 22CR50955.

The evidence for this complaint comes primarily through two sources. Both of these documents are posted on www.haywoodtp.net .

1. Nine (9) pages of meticulous hand written notes I took during the court hearing on 10/11/2022, Lois Hollis v. Ed Smathers, 22CVD401/22CR50955 at 2:18 pm before Judge Monica Leslie, until the conclusion at around 7:00 pm.

Part 1. Representation of a defendant who is not his client.

On 4/22/2022, Ed Smathers committed the Offence of I M -ASSAULT ON A FEMALE, 22CR50955, on Lois Hollis. See the video of the assault on www.haywoodtp.net

Lois Hollis filed two complaints, 22CR50955, a criminal complaint for the assault, and 22CVS401, a civil complaint, requesting a 50-C, no contact order.

As the two cases progressed through the court system, the two cases/complaints eventually merged together, both to be heard at the same time before the judge. Ed Smathers eventually retained Zeb Smathers as his lawyer for the criminal case, but never retained him for the civil action, 50-C.

Both cases were heard on 10/11/2022 before Judge Monica Leslie. The prosecution for the State, was Chief ADA Jeff Jones, with Zeb Smathers defending Ed Smathers in the criminal case. Lois Hollis was Pro Se with the civil case, 22CVS401, and since Ed Smathers had not retained Zeb Smathers for the civil case, Ed Smathers should have been defending himself before the Judge. Instead, Zeb Smathers defended both cases.

The following email is a confession by Zeb Smathers that he did not represent Ed Smathers in any civil matters. The email to me is dated 12/5/2022.

I created two (2) copies of my handwritten notes from 10/11/2022, and then used yellow highlighter marker to highlight items for each of the two instances of the complaint:

- **Exhibit 3** - Yellow highlighter showing all instances of Zeb Smathers involvement with the 50-C portion of the hearing, which included Zeb Smathers badgering the hell out of Lois Hollis when she spoke before Judge Monica Leslie. Zeb Smathers did not represent Ed Smathers on any civil matters, yet, Zeb Smathers was the one speaking for Ed Smathers. The first words Ed Smathers spoke, was at 5:53 pm when Zeb Smathers called Ed Smathers to take the stand, who swore on a Bible to tell the truth, the whole truth, and nothing but the truth.
- **Exhibit 4** - Yellow highlighter showing all instances of Zeb Smathers involvement with Dissuading Witnesses.

Exhibit 3 Summary.

Summary of Zeb Smathers actions of the hearing, from the aspect of Zeb Smathers involvement of the civil portion of the hearing, the 50-C. This is summarized page by page, noting the time, of what happened.

Page 1

2:38 Zeb Smathers requested a pre-hearing discussion of the 50-C, calling out Lois Hollis, Joe Lipari and Jeff Jones. Eventually including Ed Smathers. Reason, Zeb Smathers trying to make a deal. Zeb Smathers would give Lois Hollis the 50-C if she would drop the assault charge. Lois Hollis did not trust Zeb Smathers, she declined.

3:14 After Lois testified, there was discussion on the 50-C. Zeb Smathers started asking a series of questions of events prior to the assault, wanted exact dates of rocks being thrown. He was badgering Lois Hollis - who can remember exact dates of stuff that occurred over a year ago. Zeb Smathers was grand-standing.

Page 2

Zeb Smathers cross on 50-C. He was badgering the Pro Se.

Zeb Smathers to Lois - "You dropped your phone, didn't you". Inquired about the Police Report. Accused Lois Hollis of speeding up the road (you can't speed up that road!) Zeb Smathers laid out a scenario of absolving Ed Smathers.

Page 3

Lois asked Joe Lipari, who took the stand, about aspects of the 50-C

Noreen Lightford took the stand, a character witness for Lois.

Zeb Smathers interacted with Noreen Lightford, which should have been done by Ed Smathers.

Page 4

5:25 Indication that the 50-C would be or was dismissed.

Page 6

5:53 Zeb Smathers called Ed Smathers to the stand. These were the first words Ed Smathers spoke, was at 5:53 pm when Zeb Smathers called Ed Smathers to take the stand, who swore on a Bible to tell the truth, the whole truth, and nothing but the truth.

So, if these were the first words that Ed Smathers spoke, who the hell was arguing before the court about the 50-C? It was Zeb Smathers.

Part 2. Dissuading witnesses in cases 16CR053432 and 22CR50955/22CVS401.

This section includes information from two (2) sources -

1. **Exhibit 4** - Yellow highlighter showing all instances of Zeb Smathers involvement with Dissuading Witnesses, from my handwritten notes taken in court on 10/11/2022. In this instance, witnesses provided false testimony
 - Ray E. Roberts
 - Ed Smathers

2. Recollection of events related to 16CR053432 on 2/7/2017. In this instance, witnesses provided false testimony
 - CHARLES DOUGLAS WRIGHT
 - Ken Henson
 - Cornelia Cree
 - Lynda Bennett

Zeb Smathers defended CHARLES DOUGLAS WRIGHT in case 16CR053432 on 2/7/2017, in front of Judge Donna Forga. Zeb Smathers called, as witnesses, Ken Henson (Zeb Smathers father-in-law), Lynda Bennett (failed US Legislative Candidate), Cornelia Cree (forced to resign as Board Member from Haywood Board of Elections), and CHARLES DOUGLAS WRIGHT himself, who threatened me by saying “BACK OFF OR ELSE THERE WILL BE BLOOD RUNNING OUT BOTH YOUR EARS”. Kate Wren was the ADA for the state (me).

As each of these people, who had been sent out to the outside hallway until it was their turn to testify, were perfectly choreographed, when asked - “Did you hear CHARLES DOUGLAS WRIGHT say “BACK OFF OR ELSE THERE WILL BE BLOOD RUNNING OUT BOTH YOUR EARS”?”

As each witness called by Zeb Smathers swore an oath to tell the truth, nothing but the truth on a Bible, he asked them if CHARLES DOUGLAS WRIGHT had threatened me. Each one lied their [expletive deleted] off and said they did not hear CHARLES DOUGLAS WRIGHT say “BACK OFF OR ELSE THERE WILL BE BLOOD RUNNING OUT BOTH YOUR EARS”.

Judge Donna Forga bought into convincing testimony by

- CHARLES DOUGLAS WRIGHT
- Ken Henson
- Cornelia Cree
- Lynda Bennett

and dismissed my case!

So, as you can imagine, I will never believe anything that comes out of the mouths of any of these people ever again as long as I live, and I am not happy with Zeb Smathers.

It was Déjà vu all over again when Zeb Smathers called Ray E. Roberts and Ed Smathers as witnesses against Lois Hollis in 22CR50955 on 10/11/2022. The drill was the same, Zeb Smathers keeping everyone out in the hallway outside the court until it was their turn to testify.

Refer to **Exhibit 4**, appended to the end of this Grievance. This is where Ray E. Roberts and Ed Smathers were called to the stand, and Zeb Smathers was attempting to pull the rabbit out of the hat, leading both of them towards absolving Ed Smathers of the assault. Clearly, each witness was choreographed, but this time, their testimony was shattered and smashed to bits by ADA Jeff Jones, who blew holes in both their testimonies. Too bad Kate Wren could not have done that for me in case 16CR053432, but she only had a half an hour of prep time for my case.

This time, the Judge did not buy it. Why? Because there was a video!
