Subject: Davenport announces Detention Center will cost \$21.5 Million + \$10M New Library + New HCC...

Ted Cole of Davenport & Company casually announced at the last county commission meeting during the Administrative/Agency Reports/Presentations portion of the agenda showing slides of tiny numbers that no one could see, that:

"The County has identified the following capital projects as near-term priorities that could be funded within the next year:

## - County Projects

- Detention Center: The County is planning to expand its existing Detention Center Facility. Moseley Architects is serving as the architect, and the project is anticipated to be bid in the Spring of 2023. The total estimated cost of the expansion is \$19,796,315. For purposes of this analysis, the project is estimated at \$21,500,000.
- Library: The County is considering a renovation of the existing library to occur as early as Spring of 2024. For purposes of this analysis, the renovation is assumed to cost \$10,000,000.

## - Community College Projects

- Haywood Community College has identified a need to construct a new General Education and Early College Building for a total estimated cost of \$37,220,000. For purposes of this analysis, the financing is assumed to occur in the Spring of 2026.

## WTF?

Who is Davenport in the first place? It appears that the County has hired a high-priced Financial Advisor Company to analyze how to deal with debt. In the past, this is something that the past Haywood County Finance Director, **Julie Davis**, could do in her sleep. Now we have a Finance Director, **Kristian Owen**, that cannot come up with a single calculation for a Revenue Neutral Tax Rate. ### **Detention Center.**

Remember back on 7/24/2020 when Jeff Haynes introduced the Moseley Architect Plan for a New Detention Center? The projected cost was \$16,422,804.22. On www.haywoodtp.net

Then on 6/6/2022, county commissioners gave Moseley \$1,985,000.

County Commissioners approved \$1,985,000 to Moseley Architects for architecture and engineering services for the proposed Detention Center (New Jail) on 6/6/2022. Here is the result for nearly \$2 Million. (More Missing Millions?) 6/6/2022. 10/18/2022...

Davenport announced the project is now \$21,500,000. Does that include the \$1,985,000? Does that include possibly moving into the area of the current garage and the trash drop off service center adjacent to the Sheriff's Office? If so, has the cost of replacing those facilities and locations be factored into this \$21.5M cost?

There has to be a point in time where you step back and re-examine this whole thing. The justification for the new detention center was based on overflow of the current facility, and having to pay money to other county's to house the overflow. At what point does that become moot?

\$16.4M \$21.5 + \$2M \$30M \$40M \$50M

I don't know, but each new estimate of the detention center is increasing almost exponentially, and the county has not even received the first bid. It is a question county commissioners will need to ask.

This has been a pipe dream for **James Weaver "Kirk"Kirkpatrick the III** ever since he was appointed to sit on the Library Board.

Remember when the Library Renovation was \$4M, then \$6M, then \$8 - \$10M, finally \$10M? On www.haywoodtp.net
