Subject: Goliath Wins. Town Of Waynesville Zoning Board of Adjustment sides with Teague.

The Town of Waynesville Zoning Board of Adjustment refused to grant Peggy Hannah an Appeal of Administrative Decision, siding with **Elizabeth Teague**, saying she did everything right. Peggy Hannah now has thirty (30) days to file an appeal with Superior Court, if she decides to do so.

There were several interesting aspects to this Zoning Board of Adjustment meeting, which I will list in 'bullet' form.

- There were five board members present, a 'super' quorum. I was not familiar with any of these people.
- Ron Sneed, previous Planning Board lawyer, was evidently dragged out of retirement to give a 10 minute presentation to audience members about what was going to happen at this meeting. It was to be a Quasi-Judicial Hearing. It was to be presided over by the chair, George Escaravage.

Quasi-Judicial hearings in the past are notable. Ginger Hain ran the worst one I can remember, and poor Doyle Sutton, when he got sandbagged by **Frank Queen** and **Kevin "Adjudication" Ensley**. The chair is supposed to run the meeting, but **Kevin "Adjudication" Ensley** could not run a Quasi-Judicial Hearing to save his life.

I have to say, the meeting last night was run professionally, ran at a fast pace, and as far as I can tell, Escaragave only made a couple of mistakes (allowing people to testify that were not sworn in). However, it did appear to me that all of the board members had their minds made up before the appeal even started.

• There were a couple of chinks in **Elizabeth Teague's** armor.

In her "Background" statement, she said: <u>"The Haywood County detention facility does not provide correction or rehabilitative services to detainees.</u>" They sure as [expletive deleted] do! Chief of Deputies, Matthew Trantham, who attended the meeting, said there were currently six (6) people who were being incarcerated that were being held for <u>correction</u>. Additionally, previous Sheriff Greg Christopher instituted a Peer Support Program, including people he had offices directly in the detention center, **Rick Marvin** and **CJ Deering**. Finally, Sheriff Wilke indicated that there was Thru Care activity being conducted. Does anyone know what "Thru Care" is? Search <u>www.haywoodtp.net</u>.

Both **Bryant Morehead** and **Kris Boyd** were at the meeting, quiet at little mouses. The chair mentioned to Peggy Hannah about having the garbage station moved directly in front of her house with no barriers, but said there was no indication of it being moved from the evidence that he had before them, otherwise, it may have changed his position.
