#### SUMMARY NARRATIVE

Sir, I was dispatched to 224 E. 46th St. for a report of a disorderly person. Upon my arrival I made my way to the front door. As I approached I could hear a male voice yelling, but I was unable to determine what was being said as the voice was coming from the rear of the residence. At that moment dispatch then advised that the call taker had heard over the phone the male strike a female, then take the phone and break it. I requested dispatch to confirm this which they did. I immediately knocked on the front door and further heard agitated male and female voices. The arrestee (Cory Vaillancourt) answered the door and I requested he step back inside. Mr. Vaillancourt refused. I then ordered Mr. Vaillancourt back inside as I could the female but could not see her condition. I then stepped toward Mr. Vaillancourt who put his right forearm to block my advance and attempted to quickly close the front door with his left as I could hear and caught a glimpse of the female approaching. I then turned Mr. Vaillancourt around by the arm and placed him handcuffs for investigative detention to determine

the welfare of the female/reporting party (Lisa Semple). I then escorted Mr. Vaillancourt inside and placed him on the stairs. Ms Semple advised that herself and Mr. Vaillancourt had been involved in a loud verbal altercation that had stemmed from a earlier argument. Ms. Semple stated that Mr. Vaillancourt had become very disorderly, yelling and cursing at her. Ms. Semple advised that Mr. Vaillancourt's actions had placed her in such, "fearful for my safety," that she called police. Ms. Semple stated that while on the phone with dispatch Mr. Vaillancourt grabbed the phone from her and "stomped" on it. The phone, a silver Motorola flip-style Model V3C, was in three pieces and had the front panel shattered. Ms. Semple stated Mr. Vaillancourt did not strike her and had no visible injuries, Ms. Semple also refused EMS. I then returned to Mr. Vaillancourt and advised him, that he had been placed in investigative detention due to the situation. I then advised Mr. Vaillancourt that he could speak with me about the incident, but that in no way was he required to and it was his right not to. Mr. Vaillancourt stated he would gladly speak to me about the incident. I then asked Mr. Vaillancourt to explain the situation. Mr. Vaillancourt stated he and Ms. Semple had been involved in a verbal altercation. I then asked Mr. Vaillancourt how the phone came to be broken to which he stated, "Oh, I did that. She had the phone and I took it and broke it." I then advised Mr. Vaillancourt that he was under arrest for "Obstruction of a Emergency Phone Call" under the Domestic Violence Act. Both Mr. Vaillancourt and Ms. Semple advised that the two had been living together for over two years. Mr. Vaillancourt was transported to CCOC by way of the cruiser. The cell phone was collected, taken to headquarters, and logged in as evidence. Ms. Semple was given a CRN and advised of possible remedies.
