Mr. Smart advised he opened the front door to find several "Don Smart for Governor" signs thrown on the front step. Mr. Smart stated it appeared these were the signs that had been standing in his front and the yard of his neighbor. Mr. Smart advised he then noticed a male walking away. Mr. Smart advised he noticed him and came back. Mr. Smart advised he recognized the male as the suspect (Cory Vaillancourt). Mr. Smart stated Mr. Vaillancourt smelled of alcohol and behaved in a disorderly manner. Mr. Smart advised that after Mr. Vaillancourt left he called police. Mr. Smart advised that Mr. Vaillancourt he telephoned him twice before my arrival. Mr. Smart advised Mr. Vaillancourt made the statement "I hope your glad, the black guy won."
