Mr. Fowler, you only showed me video from approximately 9am for a duration of 45 minutes or so on 7/12/2023.

I would like to review surveillance video, specifically, the motion detected camera which faces down the hall of the family changing room and the women's locker room, from 1:30pm - 3:30pm, and more specifically between 2:00pm and 2:30pm on 7/12/2023. I would like Chief Adams to be present. Don't care if Martha Sharpe Bradley is there or not.

Additionally, I would like to be escorted into both the women's locker room and sauna for the purpose of taking photo's of each room, and again would appreciate Chief Adams being present. I would like to be able to establish a baseline for correlation of the inside of the women's locker room.

I am generally available any time this week, with the exception of Thursday afternoon. Let me know when I can view this video.
