When are you going to make a public apology to Jess Scott and his family?

This is about all I can expect from this bunch of people from the Town of Waynesville. Still missing:

- A Public Apology from everyone who threatened, doxxed, etc., Jess Scott, his family, friends who stood up for him and his daughter.
- Copies of the Rec Center surveillance security videos.
- Names of the two x-gender people redacted from incident reports WPD2301051, WPD2301038, and WPD2301087.

¹ WPD2301087 was further redacted my me before posting, slicing out peoples names who **Martha Sharpe Bradley** is not so equally concerned about.

When I was invited over to the Rec Center by WPD Chief Adams on 8/2/2023 to take photos of the Women's Locker Room, the Sauna, and view the afternoon surveillance security video of 7/12/2023, I took notes of key events, which I posted in Part 6 of this series. They are:

- **12:42 pm. Two underage females along with their guardian entered the women's locker room. The women's locker room as two entrances/exits. The first from the hallway behind the reception desk, monitored by the video we reviewed, and another separate access to the pool area. It is presumed that the two underage females changed clothes, left the locker room for an hour of pool fun/enjoyment. These people were identified by Chief Adams as those that appear in the new/amended incident report (WPD2301051).**
- **1:51 pm. Three he/him/her/she/they/them/it/whatever transgender female's (?) entered the women's locker room. Two were big women, and a third, in a butch haircut, blue striped pants and top, and tattoos up and down her arms and back, (blue hair ?), walked in together. These people were identified by Chief Adams as those that appear in the new/amended incident report (WPD2301051).**
- **1:58:03 pm. Seven (7) minutes later, three (3) underage females exited the women's locker room. One was older than the other two. These minors were identified by Chief Adams as those that appear in the new/amended incident report (WPD2301051).**

At approximately 1:30pm, on July 28, 2023, Det. Paige Shell met Assistant Town Manager Jesse Fowler at the Waynesville Recreation Center to review video. The timeline established is as follows:
12:40:13- [REDACTED] enter Waynesville Recreation Center
12:42:31- Family (excluding boy) walk into female locker room
12:46:09- [REDACTED] and [REDACTED] exit female locker room (back hall) & meet [REDACTED] go into pool area
1:49:23- Three females enter the Waynesville Recreation Center (one wearing blue & white jumpsuit with short hair)
1:50:58- [REDACTED] enter female locker room (back hall entrance)
1:51:59- Three females enter the female locker room (front hall entrance)
1:54:48- Three females exit female locker room (back hall) and enter the pool area
1:56:51- [REDACTED] and [REDACTED] exit female locker room (back hall) and meet [REDACTED] and other [REDACTED]
1:57:02- [REDACTED] and [REDACTED] walk into female locker room
1:58:00- [REDACTED] and [REDACTED] walk out of female locker room (front hall)
1:58:21- Three girls in the lobby area with boy
1:59:00- [REDACTED] exits female locker room (front hall)
1:59:35- [REDACTED] exit Waynesville Recreation Center

Note the exact correlation of my observations and the time line reported in WPD2301087!

So, I was wondering how **Cory Vaillancourt** was going to resolve this in his attempt to salvage his original article. He created brand new article, appearing yesterday in the smn tabloid - in effect, picking up queues from **Martha Sharpe Bradley** and **Jesse Fowler**, Lying by Omission -

So, it has been established that the person referenced in the morning surveillance security video on 7/12 and entering the sauna on 7/18, were both the same guy (had balls and a penis, yet nice boobs), who **Cory Vaillancourt** refers to as “Jane Doe”, should really be referred to as “John Doe”, and the three women entering the Women’s Locker Room the afternoon of 7/12 (verified as I was informed that all three had vagina’s), the person with the man’s voice and face stubble, who freaked out the girls, should really be referred to as “Jane Doe”.

Will we ever see a public apology?

I don’t think so.

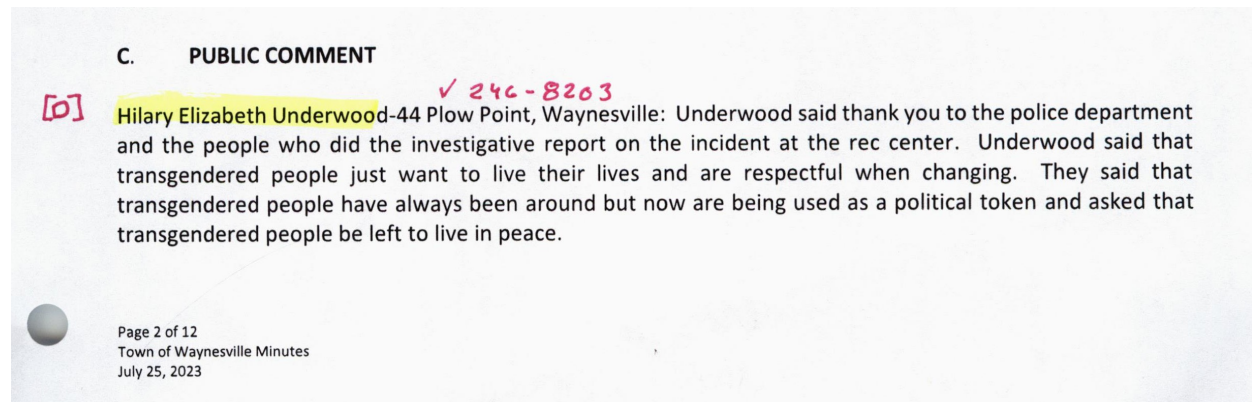

This is why these people are anxious to have the requirement for addresses and phone numbers requirement removed from future Town Council meetings.

Chelsea White-86 Wilkinson Pass Lane, Waynesville: White said that she has lived in these mountains her whole life and thanked the Town for doing their research regarding the rec center incident. She said that 90% of sexual assaults are committed by someone the victim knows. She said that no community members deserve to feel unsafe for merely existing.

Tera McIntosh-119 Winter Lane, Clyde: Dr. McIntosh thanked Town leadership and the police department for investigating the rec center incident and for not releasing Jane Doe's name. She added that transgendered people have the same rights as any other American. She also requested that Town Council not require people to give their names and addresses before speaking at public comment.

Brandon Milan-1041 Kims Cove Road, Canton: Milan said that he works in child welfare and has a degree in religion. He said that the transgendered person who visited the rec center has unfairly received threats of violence for merely existing. He asked for people not to vilify a group of people based on unfounded accusations.







Councilmember Sutton made a motion, seconded by Councilmember Freeman, to continue public comment. The motion passed unanimously.



She said that never did those assaults happened in a women's restroom. She said she wants everyone to feel safe in this Town.
