

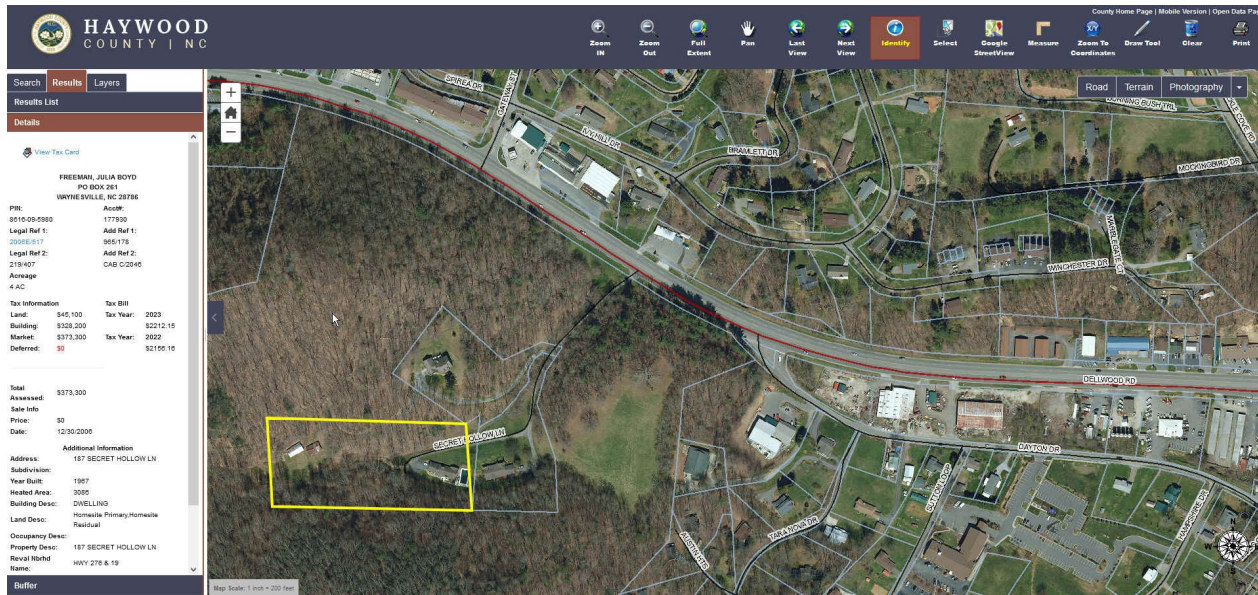

Subject: Julia Boyd Freeman - Abuse of Power. Pulling a Eve Barrett.

Julia Boyd Freeman [r]¹, currently running for her forth (4th) term for Waynesville Town Council, resides at 187 Secret Hollow Lane, Waynesville, NC 28786. 187 Secret Hollow Lane was outside of the Waynesville town limits prior to 2019, but was annexed into the town sometime in 2019, thus making it legal for **Julia Boyd Freeman** to remain on the Town Council. Prior to 2019, she resided at 60 Springview Drive, Waynesville, NC 28786. Evidently, she got a divorce, and moved to her current address, 187 Secret Hollow Lane.

Secret Hollow Lane is a cozy little street, and has three (3) homes. Going into Maggie Valley, you turn left at Dickey’s BBQ. From Haywood County GIS, the homes belong to:

- **Julia Boyd Freeman**, 187 Secret Hollow Lane, PIN 8616-09-5980
- **Mark Boyd**, 70 Secret Hollow Lane, PIN 8617-00-8298
- **Brian Boyd**, 117 Secret Hollow Lane, PIN 8617-10-1015



Evidently, someone requested that 187 Secret Hollow Lane be annexed into the Town of Waynesville on or about 2019, but not the other two homes directly adjacent to 187 Secret Hollow Lane. There is currently an open Request for Information regarding the specifics of this annexation with Olga Grooman, Town of Waynesville.

Well, how much are Mark Boyd and Brian Boyd paying in Waynesville Town Taxes?

\$0.00!

Why, because they have not been annexed into the Town of Waynesville. Only **Julia Boyd Freeman's** property was annexed into the Town of Waynesville.

WTF?

After a hit piece by **Cory Vaillancourt** of the smn tabloid, Eve Barrett was exposed for attempting to run for a Town Council member in Maggie Valley while not living in Maggie Valley, and was forced to pull out of the race. Where is **Cory Vaillancourt's** coverage of **Julie Boyd Freeman** when you need him?

Anxiously awaiting a response from Olga Grooman about the specific dates of annexation of 187 Secret Hollow Lane to insure that there were no gaps between the time **Julia Boyd Freeman** moved into her new residence and the time it was annexed.

If there was a period of time that **Julia Boyd Freeman** moved into her new residence, and it had not been annexed into the Town of Waynesville, then town records of Aldermen meetings in 2019 would have to be reviewed, as **Julia Boyd Freeman** may not have been a resident of the Town of Waynesville, and her votes would have to be reviewed.

Again, awaiting a response from Olga Grooman to determine who exactly requested this annexation. If it was **Julia Boyd Freeman** herself, for the purpose of maintaining a residence in the Town of Waynesville to remain on the Town Council, that would represent a gross Abuse of Power.
