#### What's Happening?

The purpose of this newsletter is to inform Haywood County Taxpayers of what transpires at the bi-monthly County Commission Meetings. This newsletter will be written from the perspective of a casual observer, myself. Any opinions expressed will be mine.

#### Commissioners vote to appeal 11PTC 838.

In the commissioners last secret closed session meeting on July 15, 2013, they resurfaced and authorized an appeal of a ruling by the Property Tax Commission.

[**Editors Note:** Transcript of Swanger after returning from closed session]. **Swanger:** "Okay, we have returned from closed session. We have, um, we have had a request from our Tax Administrator, um, to authorize the appeal of the North Carolina Property Tax Commission's decision in case number 11 PTC 838. Um, I will entertain a motion at this point." (So moved, seconded passed.)

What is this? You sure won't hear about it in any of the local newspapers, specifically the Mountaineer or the Smoky Mountain News!

This is a ruling by the Property Tax Commission in favor of Denny and Debbie King, and against Haywood County, and specifically, the shenanigans of the center of our universe of tax problems here in Haywood County, **David Francis**. Let's not forget to include **Cal Messer**.

The ruling said, in part:

# BASED UPON THE FOREGOING FINDINGS OF FACT, THE COMMISSION MAKES THE FOLLOWING CONCLUSIONS OF LAW:

2. In this appeal, Appellants did present evidence tending to show that the county tax supervisor used an arbitrary method of valuation; and that the county's assessment substantially exceeded the true value in money of the property.

What does all this mean to you and why is this important?

#### Revaluation.

This all started innocently enough when county commissioners approved a Schedule of Values presented by **David Francis** prior to the revaluation. The county was subdivided into "Neighborhoods", about 910 of them. Theory sounded plausible, sample a couple of "comps" (sales of comparable homes in a neighborhood) and apply those values to average assessed values to the entire neighborhood.

There was considerable constipation among Haywood County Taxpayers, and significant research was done following the revaluation, including by myself, Denny King, and many others [re: www.haywoodtp.net].

The appeals process started with an "informal appeal" [David Francis and Judy Ballard], progressing to taking appeals to the Board of Equalization and Review [dominated by Mark Swanger, Mary Ann Enloe and Evelyn Cooper], and finally taken to the Property Tax Commission. The Property Tax Commission is like a court, and the presumption is that the County is right, and the Taxpayer has to prove the County is wrong. The hearing is filled with lawyers, and in this case, the County paid a high priced lawyer from Raleigh, Charles C. Meeker, from Parker Poe to represent the shenanigans of our county commissioners, David Francis and Cal Messer [re: soon to be released transcript of that hearing].

Denny and Debbie King appealed their case to the PTC and represented themselves, i.e. no lawyer.

About a month before the actual hearing, **Doug Huffman**, the PTC guy that negotiated most of the complaints of Haywood County Taxpayers after the Board of Equalization, let the cat out of the bag. He mentioned something called a <u>Neighborhood Delineation Rate</u>. The rate for Denny Kings property was 1.30. That means 30% above 100%. [re: neighborhood 02R021].

What was this?

This, it turns out, was the "Ah-ha" moment!

During the hearing, as the Kings were refuting the "comps" used by **Cal Messer**, **Cal Messer** said - "we didn't even use those comps".

What?

**Cal Messer** said the King's lived in a "pristine area", and therefore they (and their entire neighborhood) were assigned a premium.

They can't do that.

It was all downhill after that for **Charles C. Meeker**, **David Francis** and **Cal Messer**.

PTC commissioners asked **Cal Messer** during the hearing if they ruled in favor of the King's, would he go back and adjust their assessed value downward. **Cal Messer** said he would.

**Cal Messer** has yet to revise the King's assessed value to remove the premium 30% that was arbitrarily applied.

What is this costing the Haywood County Taxpayers? There are three costs that Haywood County Taxpayers ought to be excited about.

- The direct cost of the litigation for sending **Meeker**, **Francis**, **Messer**, and **whoever**, to Raleigh for the trial, and all of the costs associated with preparation for the trial;
- The cost of the appeal, which is going to cost us God Knows What, and what business do they have appealing in the first place;
- Lastly, since the county wrongly applied this Neighborhood Delineation Rate to 02R021, the King's neighborhood, how many other neighborhoods was this applied to? It turns out about 100 of the 910 neighborhoods are above 100%. If the county has to come back and adjust all of those back to 100%, they will have to drop \$\$\$Millions\$\$\$\$\$ off the tax role and AD Valorem revenue. They will have to make up this short-fall in revenue for a drop in county services. They sure as hell are not going to raise taxes. If they do, Kirkpatrick, Upton and Sorrells will get bounced out of office at the next election so fast, it will make your head spin.

#### What is your over-assessed value?

No one knew about this. I did not know about this. The King's requested and received two documents from the Tax Department (one appended to the end of this newsletter) which identifies the Neighborhood code, the appraisal rate, and on a separate document, the neighborhood identification (not attached).

I, as I am writing this, am looking up for the first time, what my rate is.

Here is how I am looking this up...

Go to www.haywoodnc.net,

Select Maps Online

Click OK, Go to Maps Online

Type in your first and last name in the look-up box Find your address if there is more than one result Click Details

Go to the bottom of the results and click <u>View Tax Card</u> About halfway down the page, under MISCELLANEOUS INFORMATION, you will see Nbrhood:

Mine is 16R008.

Looking this up on the Appraisal rate document at the end of this newsletter, my rate is: 0.00

My rate is 100%. What is yours?

A rate of 1.30, or 130%, as with the King's neighborhood, means that if you had a property originally assessed at \$100,000, after this "adjustment" by **Cal Messer & co.**, you would be paying tax on \$130,000.

#### Commissioner's Deed.

What is a Commissioner's Deed, and why am I asking this question?

Reviewing the different types of Deeds from the last issue of Toeprints -

There are two (2) basic types of foreclosures, as explained to me by Sherrie Rogers, Register of Deeds.

- <u>Sheriff's Deed</u> This is a type of foreclosure that is initiated by the county, **David Francis**, for non-payment of taxes.
- <u>Trustees Deed</u> This is a type of foreclosure that is initiated by a lender (bank, for example) when a property owner fails to keep up on mortgage or other payment schedule.

A Commissioner's Deed is one that a lawyer(s) is/are appointed to go through a **special proceeding** to resolve the sale of a property, such as if someone dies and a bunch of relatives would like a portion of the distributed property.

It was brought to my attention that one such Commissioner's Deed has **Kirk Kirkpatrick's** name all over it. **Kirk Kirkpatrick** happens to be a county commissioner, but there is no connection with **Kirkpatrick** being a county commissioner and him being a Commissioner on this deed. Simply a coincidence.

The reason this Commissioner's Deed was brought to my attention is that the older woman that recently passed away that had owned this property was located in the same Delineated Neighborhood as the King's, 02R021. Her name was Louise Scott, PIN 8669-27-5622, Deed Book 836, Page 559-561, case # 11SP461. **Kirkpatrick** was responsible, as commissioner, for selling this property, distributing the assets to the Grantors, and, of course, collecting a fee (\$8,397).

**Kirkpatrick** was appointed Commissioner to this case by **June Ray**, Clerk of Superior Court.

Kirkpatrick sold the home (dubwad - translation: double wide trailer) and property for \$62,000. Prior to the revaluation, that appeared to be around the original assessed value (records are hard to get hold of, remember, have to deal with **David Francis** here). The sale was completed on November 30, 2012.

The mobile home was built in 1998, and as we all know, mobile homes depreciate in value, like a car. But not in the land of **David Francis**. The assessed value shot up to \$116,800!

What?

#### Again, the assessed value shot up to \$116,800!

Well here is a question for **Kirkpatrick**. Why didn't **Kirkpatrick** sell the property for \$116,800, the value his boys **David Francis** and **Cal Messer** assessed it for? Why did he have to settle for \$62,000?

Because that was the fair market value of the property. Yet this [expletive deleted, expletive deleted, expletive deleted] county commissioner **Kirkpatrick** voted to appeal 11PTC 838 on July 15, 2013. How in the [expletive deleted] is **Meeker, Francis** and **Messer** going to explain this little fiasco at the PTC appeal?

How, commissioner **Kirkpatrick**, do you explain only being able to sell this property for \$62,000 when it was assessed at \$116,800, when you are appealing 11 PTC 838?

#### Legal Costs.

The county has not provided realistic legal costs incurred thus far for **Meeker**, and other aspects to date.

In a letter to **Marty Stamey** on January 22, 2013, I asked **Stamey**: "Who paid for Francis, West and Messer to make the trip to Raleigh, and how much did that lawyer (who lost the case for you) cost?"

Response - none.

In a Request for Public Information from Jonnie Cure to **Julie Davis**, Haywood County Financial Director, she asks:

Julie please provide me with complete expense reports and all costs related to the King vs. Haywood County hearing before the Property Tax Commission on Friday, Jan. 18, 2013.

Please include all costs to Haywood County to defend the County against Denny E and Deborah C King's appeal of the decision of the 2011 Haywood County Board of Equalization and Review (County Board).

Please include all attorney fees for Charles Meeker (Parker, Poe, Adams and Bernstein law firm) and any other law firms or attorneys and any and all expenses for the group of County employees who were sent to the hearing at the Property Tax Commission on Friday, Jan 18, 2013.

Jonnie.

I have been able to pull together some costs that have been posted related to the appeals in January 2013. Travel and attorney fees for the appeals at that time come to \$6,831.57. This may include appeals other than the King appeal, as the invoices are posted in total. I have tried to see if anyone has been keeping record of the expense separately, and have, so far, not found any information that is better segregated. If I happen to get this information in the near future, I will certainly send it to you.

#### Julie H. Davis, Finance Director

It was brought to my attention that **Charles C. Meeker**, from Parker Poe, created a (thick) black notebook which he provided to the King's containing Exhibits to be used at the PTC hearing. My guess is that the cost of the material for that notebook closely approaches the value that Julie Davis provided for the entire cost of this fiasco.
