**Public Comments - 4/18/22 County Commission Meeting.** Eleven (11) people spoke during the Public Comment Session of the County Commission Meeting on 4/18/2022. All spoke addressing county commissioners on the relevance of questionnaire/scorecard aimed at assisting voters make informed decisions at the May 17<sup>th</sup> primary election.
